# New Financial Policies



- 1. To support the small and micro enterprises, the Ministry of Finance and the State Administration of Taxation issued the Announcement on VAT Relief and Other Policies for Small-scale VAT Payers (CAISHUI [2023] No.1), which provides:
- (1) From January 1, 2023 to December 31, 2023, small-scale VAT payers with monthly sales of less than 100,000 Yuan (inclusive) will be exempt from VAT.
- (2) From January 1, 2023 to December 31, 2023, VAT For small-scale payers whose taxable sales are subject to the 3% levy rate shall be subject to a reduced 1% levy rate; VAT items subject to 3% prepayment rate shall be reduced to 1% prepayment rate.
- (3) From January 1, 2023 to December 31, 2023, VAT mark-up deduction policy is subject to the following provisions:
- A: Taxpayers of producer services are allowed to deduct the tax payable with a 5% mark-up on the basis of the deductible input tax for the current period. Taxpayers of producer services refer to taxpayers whose sales of postal services, telecommunication services, modern services and consumer services account for more than 50% of the total.
- B: Taxpayers of consumer services are allowed to deduct the tax payable with a 10% mark-up on the basis of the deductible input tax for the current period. Taxpayers of consumer services refer to taxpayers whose sales from consumer services account for more than 50% of the total.
- 2. In order to support the innovative development of enterprises and the opening up of the capital market, the Ministry of Finance and the State Administration of Taxation issued the Announcement on the Extension of Preferential Policies on Individual Income Tax (CAISHUI[2023] No.2), which announces:
- calculated on special account for listed companies contained in the Announcement on Continuation of Preferential Policies for Individual Income Tax Including Annual One-time Bonus [MOF & SAT (2021) No.42] of the Ministry of Finance and the State Administration of Taxation shall remain valid from January 1, 2023 to December 31, 2023.
- (2) The preferential individual income tax policy contained in the Announcement of the Ministry of Finance, the State Administration of Taxation and China Securities Regulatory Commission on the Continuation of the Individual Income Tax Policy in Connection with Shanghai- Hong Kong and Shenzhen-

Hong Kong Stock Market Connect Mechanism and the Mutual Fund Recognition between Mainland and Hong Kong (MOF, SAT & CSRC [2019] No. 93) shall remain valid from January 1, 2023 to December 31, 2023.

- 3. In order to expand the use of digital electronic invoice (hereinafter referred to as "electronic-invoice"), with the approval of the State Administration of Taxation, Qingdao Municipal Taxation Bureau has decided to pilot on electronic invoice and therefore issued the Announcement of Qingdao Municipal Taxation Bureau on Piloting Digital Electronic Invoice (QING[2023] No.1), which provides:
- (1) Starting from January 28, 2023, piloting on electronic invoice will be commenced among some taxpayers in Qingdao, covering: (1) Taxpayers registered before January 28, 2023 and have been using VAT invoice management system to issue VAT special invoice and VAT general invoice; and (2) Taxpayers registered before January 28, 2023 and need to use VAT special invoice and VAT general invoice.
- (2) The taxpayers who use the e-invoice service platform shall be the pilot taxpayers, and the pilot taxpayers shall be determined by Qingdao Taxation Bureau of the State Administration of Taxation.
- (3) The drawees of the invoices issued through the e-invoice service platform can be nationwide.
- (4) The tax authorities shall control the total amount of the invoice issued by the pilot taxpayers. The total amount refers to the upper limit of the total amount of invoice issued by the pilot taxpayer (VAT exclusive) within a calendar month.
- (5) Pilot taxpayers can deliver electronic invoices via the digital tax account of the e-invoice service platform, or via email, QR code and so on.
